# Note on instructions

For the ComEx modules type 07-33\*\*-\*\*\* there are a large number of control and signal device actuator are available in different versions. All control and signal device actuator are made of high-quality thermoplastic and can be used in almost all potentially explosive areas.

The Control and signal design devices enables easy and safe mounting and can be complemented by useful accessories. The components are developed and certified for global hazardous areas.

The control and signal device actuators may be used only within the specified service and operating temperature.

Utilisation in areas other than those specified and the modification of the product by any one other than the manufacturer is not permitted and will exempt BARTEC from liability for defects and any further liability.

Incorrect installation can cause malfunctioning and the loss of explosion protection

Only service technicians who are authorized to work in potentially explosive atmospheres may do any of the assembly, disassembly, installation, commissioning, maintenance, and fault clearance work.

The generally applicable statutory rules and other binding directives relating to workplace safety, accident prevention and environmental protection must be observed.

When setting up or operating explosion-resistant electrical systems, IEC/EN 60079-14 and all relevant installation and operating regulations must be observed.

The control and signal device actuators may be used only if it is in a clean and undamaged condition. It is not permissible to modify the actuators in any way.

# Transport, Storage

- Only authorized and qualified personnel may do any of the assembly, disassembly, installation and commissioning work.

# Assembly/Disassembly



#### **NOTICE**

Damage to control and signal device actuators due to incorrect installation dimensions.

The minimum spacing between the mounting holes must be observed.

# Commissioning

Before commissioning, check that:

- The device has been installed correctly.
- The device is not damaged.

#### Installation

#### **Schedule of Limitations**

The following limitations relate to safe installation and/or use of the components.

- When the components are installed to electrical equipment, the service temperature of the components shall be within -55°C to +70 C.
- Under certain extreme circumstances, the component may be considered to be a potential electrostatic charging hazard. The risk of electrostatic discharge shall be minimized as stated in IEC 60079-0 clauses 7.4. and 7.4.3.
- The control and signal device actuators, type 07-3400-A\*\*\*/\*\*\*\* (push button), and type 07-3400-P\*\*\*/\*\*\*\* (mushroom push button), shall only be used in combination with the BARTEC modules type 07-332\*-\*\*\*/\*\*\*\* or type 07-3382-\*\*\*/\*\*\*\*.

- To confirm with IEC 60947-5-5 & UL 60947-5-5 the E-stop twist and pull to release actuators 07-3400-R\*\*\*/\*\*\*\* & 07-3400-N\*\*\*/\*\*\*\*, have to be used in combination with the ComEx Modules. (combinations of E-stop twist with 4-pole ComEx switch module type 07-3382-\* is not allowed. In addition, a yellow background is required, which can be created using the BARTEC background sticker 05-2144-1097 or protective collar 05-0032-0019.
- In the case of the pushbutton type 07-3400-A\* and double pushbutton 07-3400-C\*, it is absoluty necessary to attach an enclosed colored label.

# Maintenance and Fault Clearance



#### WARNING

#### Risk of injury due to incorrect proceedings.

- Only authorized qualified personnel may do any of the work relating to maintenance and fault clearance.
- IEC/EN 60079-17 and all relevant installation and operating regulations must be observed.

It is recommended to formulate a maintenance plan according to standards.

#### WARNING

#### Risk of serious accidents due to damaged parts.

 Check actuators regularly for cracks and damage. Make sure that they are properly established.



#### NOTICE

#### Damage to actuators due to incorrect cleaning.

 It is not allowed to clean control and signal device actuators with compressed air.

The operator of the control and signal device actuators must keep it in good condition, operate it properly, monitor it and clean it regularly.

The owner/managing operator must schedule maintenance intervals which will suit the respective conditions of use.

#### Fault Clearance



#### WARNING

#### Risk of serious injury due to use of non-original spare parts.

• Use original parts only as replacements.

The control and signal device actuators are defective if it no longer actuates the attached command equipment or if the illuminated disc becomes damaged. Defective actuators cannot be repaired.

Defective control and signal device actuators can be taken off and replaced by functioning actuators of the same type considering this operational instruction.

# Disposal



#### NOTE

Environmental damage can be caused by incorrect waste disposal. When in doubt, local authorities or specialist disposal companies can provide information on environmentally friendly disposal.

The components in the switch module contain metal and plastic parts. Therefore the statutory requirements for disposing of electronic scrap must be observed.

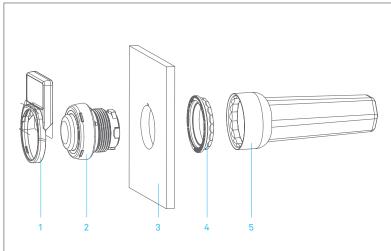

#### Mounting of the actuators

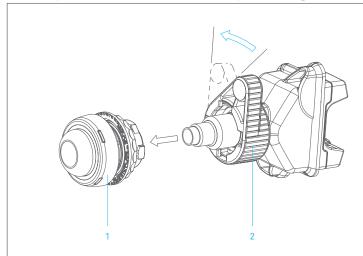


- 1 shield holder
- 2 Control and signal device actuator
- 3 Enclosure with wall thickness of 1 to 6 mm (0.04 to 0.24 in) with a mounting hole 30.3<sup>+0.3</sup> mm (1.2+0.01 in)
- Fixing nut, must be tight a torque of 2.8 3.4 Nm (2 2.5 lb.ft)
- 5 Torquing tool

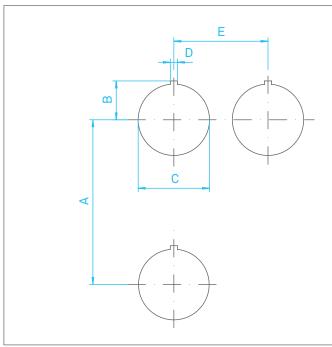

Mounting hole with cut-out for anti-twist protection, typical position: top (12 o'clock position).

Minimum spacing for the mounting boreholes:

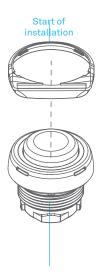
- horizontal 40 mm (1.6 in)
- vertical 70 mm (2.8 in)

Chamfer or rounding from 0.1 mm up to 0.3 mm (0.004 up to 0.01 in) on outer surface of hole is required.

If the control and signal device actuators and modules are not placed directly below each other in a grid structur, the row spacing of 75 mm must be maintained.

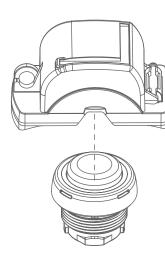
#### Marking clip/Shield holder



Position of the anti-twist protection

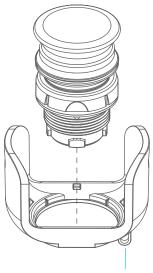
When mounting, first hook the marking clip/ shield holder into the attachment from above on the marked side and then latch it into place by pressing it into the opposite side. Note the position relative to the anti-rotation device.

#### Locking device



Attach the holding frame of the locking device to the actuator from above.

#### Protective collar



Optional:
Attachment of the latch
with ball chain. Thread
the ball chain through and
close the clamp closure

Slide the protective collar onto the actuator from below as far as it will go. Note the position relative to the anti rotation protection. Optionally, the seal of the actuator can also be removed and reattached after sliding on the protective collar.
